Regular Town Board Meeting - Monday, April 10, 2017 - 7:00 pm - Linn Town Hall

Chairman Weiss called the meeting to order at 7:05 pm. Present at roll call were Chairman Weiss, Supervisors Jones, Rasch, White, Palmer, Clerk/Treasurer Polyock, Atty. Schiltz. There were about 18 people present.

Oaths of Office were given to Police Officer Sarah Rabic, Chairman Weiss, Supervisors Jones and Rasch, Clerk/Treasurer Polyock.

Jones/White motion to approve minutes of all March 2017 meetings as distributed. Carried.

White/Jones motion to approve payment of bills distributed in Board packet and also those distributed tonight. Carried.

Comments from the public: Steve Mack commented on the race to be held Sunday, May 28<sup>th</sup> along the shore path. Who is going to make sure the participants stay on the path. His concern is people coming up by the houses or down on their piers. It is a problem.

Tom Leith asked about dead trees on a neighboring property on N. Lakeshore Drive.

Dick Malmin addressed helping to fund the Linn/Hebron cemetery – thinks it is a great idea.

Correspondence received by Board members: Jones, Rasch, Weiss – Tom Leith tree issue White, Palmer – nothing

Chairman Weiss asked to go out of order to item 9a. Building inspector, Joe Mesler, recommends opting out of SPS 327 as he does not think the Town has any campgrounds. The Town will be governed by County Zoning. Atty. Schiltz also recommends opting out of SPS 327. Jones/Rasch motion to opt out of SPS 327 Camping Units. Carried without negative vote.

9b — Representatives from Hebron Township distributed a packet which contained a funding proposal including the fixed costs and repairs needed for the cemetery. Atty. Schiltz has concerns in that the public purpose doctrine prohibits spending money on something that is private. Supervisor Jones stated that the Department of Justice said funding cannot be given as it is not in the State of Wisconsin. They also said a referendum must be held. Atty. Schiltz stated an option may be a deed that shows joint ownership. It was suggested perhaps forming a

"friends group" to help by donating time or money. The Board concluded the need to continue with the process and to explore more options including that of joint ownership.

Rasch/Jones motion to deny the use of Linn Road/Lakefront as an exchange point for My Team Triumph holding a race on Sunday. May 28, 2017. Carried without negative vote.
