

## EMERGENCY SERVICES AGREEMENT

THIS AGREEMENT ENTERED INTO THIS 26<sup>TH</sup> day of NOV, 2010, by and between the Village of Williams Bay, hereinafter referred to as "Village", and the Town of Linn, hereinafter referred to as "Town".

It is agreed as follows:

1. **Term:** The term of this Agreement shall commence on the 1st day of January, 2011, and shall be for a term of three (3) years to expire December 31, 2013. Provided, that on or before September 1st of each year of the term of the Lease, either party may terminate the Lease by delivery of notification in writing to the other party of the intent to so terminate the Lease. In the event such written notice is timely delivered, the Lease shall terminate as of December 31st of the year in which the notice is delivered.
2. **Compensation:** The Town agrees to pay the Village \$22,000.00 (twenty-two thousand dollars) for calendar year 2011, for fire service calls to the designated response areas of the Town as specified in this agreement. The Town agrees to pay the Village \$24,000.00 (twenty-four thousand dollars) for calendar year 2012, for fire service calls to the designated response areas of the Town as specified in this agreement. The Town agrees to pay the Village \$28,000.00 (twenty-eight thousand dollars) for calendar year 2013 for fire service calls to the designated response areas of the Town as specified in this agreement
3. **Payment due:** The Town agrees to pay the village twice a year, one-half payment \$11,000.00 (eleven thousand dollars) on or before February 1, 2011 and the remaining balance of \$11,000.00 (eleven thousand dollars) on or before August 1, 2011. For 2012, the Town agrees to pay the village a one-half payment \$12,000.00 (twelve thousand dollars) on or before February 1, 2012 and the remaining balance of \$12,000.00 (twelve thousand dollars) on or before August 1, 2012. For 2013, the Town agrees to pay the village a one-half payment \$14,000.00 (fourteen thousand dollars) on or before February 1, 2013 and the remaining balance of \$14,000.00 (fourteen thousand dollars) on or before August 1, 2013.
4. **Designated response area:** The designated response area covered by this agreement is defined as from the Village limits east to western limits of the City of Lake Geneva, south of Route 50 to the lake.
5. **Renegotiations:** The terms of this agreement shall not change from agreement to agreement, without first notifying the other party in writing of any proposed change. The Town requests to be notified of any meeting for the purpose of providing representation from the Town at those proposed negotiation meetings.


The terms of this agreement shall be in full force and effect from the 1<sup>st</sup> day of January, 2011 until the 31<sup>st</sup> day of December 2013.
